ou read about it in the November Community Improvement District 2008 newsletter! We discussed it at the 2008 Holiday Party

and the 2009 Annual Meeting, and we hope that you have had an opportunity to read about it in the Proposal! We are excited to announce that, after receiving an overwhelmingly

positive response

from so many of you, the board unanimously decided to work together with you to move forward to create Greenway Fields Neighborhood ("GFNCID"). Copies of the Proposal are available online by going to www.haccd.

Right now, the Petition to form GFNCID is being drafted. While the Petition is being drafted,

your board members will be meeting with you by going door-to-door and by hosting neighborhood meetings to discuss

When the Petition is complete, you will receive a copy of the Petition, and we hope you will join us by signing the Petition at one of several signing events that will be hosted by board members and neighbors in the near future. # Brookside Watershed Improvement Project 3A and 3B

Island area, in the 61st and Pennsylvania/Valley locale, continues. It is part of Phase 3A of the Brookside Watershed Project. Look for a community meeting in late April or early May with the Water Services Department and Burns & McDonnell, with the exact date dependent on more definitive information from the city. Also, when there is new information to share, the Brookside Improvements website will be updated.

As of the first week of February, Dennis Johnson Construction, the contractor, was about 150 feet from the end of the work area on Valley Road. The contractor was scheduled to begin 62<sup>nd</sup> Street construction once the Valley and Pennsylvania area work was completed.

Also, as of the first part of February, the Dennis Johnson Construction still had to install about 120 feet of the main storm sewer (48 " diameter pipe), a couple of fairly large junction boxes, a few curb inlets, and the smaller pipes that tie the inlets to the main system. Once the underground work is completed in this area, there will be restoration work including, but not limited to, curb and gutter, sidewalks, sod, concrete base work in the trench areas, and final asphalt surfacing,

with work on virtually all of these activities depending on the weather. Contractor crews have been working on weekends to help make up for bad-weather days that have fallen during the week. The best guess, as of the beginning of February, was that they would get the road completed up to the concrete base, and somewhat

shortly after they complete the underground work, then open the road to traffic. The final asphalt will be applied when the asphalt batch plants open in the spring.

Phase 3B, which will affect some Greenway Fields residents who live south of Meyer, will be underway as soon as funding of \$8.5 million is available. Phase 3B has been submitted to the State of Missouri as a shovel ready project for stimulus dollars as part of the Recovery and Reinvestment Act. The city should have an update from the state within the next two months. The city submitted multiple projects to the state for stimulus dollars. Phase 3B is third on the list of project priorities. The design of Phase 3B will be complete in the next 3-4 months. If funding is found, 2010 would be the earliest that Phase 3B could begin construction. 



# Greenway Fields Neighborhood Community Improvement District ("<u>GFNCID</u>") Frequently Asked Questions and Answers March 2009

### 1. What is a Community Improvement District ("CID")?

• A CID allows homeowners within a geographical area to share costs through an assessment paid by them to fund projects, such as the projects currently funded by Greenway Fields Homes Association ("GFHA").

### 2. What are the drawbacks to the process of creating a CID?

• Board members' time and GFHA's up front legal costs (one-time) to create a CID.

### 3. How will GFNCID and GFHA function together?

For all practical purposes, GFNCID and GFHA will operate in the same manner as GFHA operates now, except that GFNCID will collect assessments.

### 4. What is the primary benefit of organizing GFNCID?

• The primary benefit of organizing GFNCID is to provide for the <u>fair</u> and <u>equitable</u> payment of services and improvements currently provided by GFHA.

### 5. How are my annual GFNCID assessments for 2010 expected to compare with current GFHA annual billings?

Approximately 83% of GFHA residents currently pay annual dues, however only 40% of homeowners pay the annual security billings. On average, just over 60% of GFHA residents pay <u>all</u> assessments. Thus, approximately 60% of residents <u>subsidize</u> 40% of residents who do not pay.

The GFNCID budget for 2010 will likely be similar to the 2009 GFHA budget (which is based on an approximate 60% pay rate). As explained in the table below, the GFNCID annual assessments would be lower for homeowners since GFNCID guarantees 100% participation, thus ensuring fair and equitable payment by all homeowners.

NOTE – These are commonly-asked questions regarding GFNCID, and the answers are not intended to be exhaustive. ### 6. Is there a maximum that GFNCID could assess in any given year per household?

• The maximum amount GFNCID could assess in a given year will be stated in the petition you will have an opportunity to sign. The initial maximum amount stated in the petition will be \$172.50 and will adjust each year thereafter for inflation.

# 7. Can the GFNCID assessments be increased above the maximum amount stated in the petition without the vote or consent of the GFHA members?

No.

### 8. My property taxes are escrowed in my mortgage payment. How will GFNCID assessment invoicing work?

• Generally, if your bank pays your property taxes, the GFNCID annual assessment will be paid by your bank.

### 9. How will the GFNCID assessments be billed?

 Assessments will be included on your annual Jackson County, Missouri tax bill, thus saving traditional collection costs incurred by GFHA.

### 10. How will the GFNCID assessments be used?

• The GFNCID assessments will generally be used in the same way that the GFHA assessments are used now, and your GFHA Board of Directors will continue to develop annual budgets to fulfill its commitments to you.

### 11. What if a special project is desired by GFHA, but the money needed to fund the project is not included in the annual budget?

• GFNCID may (i) forego pursuing the special project, (ii) issue a voluntary assessment, or (iii) increase the amount of the following year's assessment (which cannot exceed the maximum stated in the petition – see question 6 above).

### 12. Can GFNCID be terminated?

Yes. A petition to terminate would have to be drafted and approved by the homeowners.

### 13. What are the next steps?

- March and April 2009 GFHA will gather homeowner signatures for the petition.
- May 2009 the petition will be submitted to the City of Kansas City, Missouri.
- August 2009 the City will render a decision.
- Fall 2009 if the City approves the petition, the first GFNCID assessment will be billed in your fall 2009 property tax bill.
