

A Tradition of Neighborhoods

he Greater Kansas City area has a proud tradition of neighborhoods and a strong network of homes associations to protect that legacy. Homes Associations of Kansas City (HAKC) is an alliance of 47 homeowners associations. HAKC includes associations on both sides of State Line.

Some people call homes associations the most representative and responsive

PODS Past Their Prime

PODS (Portable On-Demand Storage units) are driveway-sized metal boxes that are used mainly for load-it-yourself movers and for storage during renovation projects. Sometimes they store tools and equipment; sometimes they store the contents of the room under renovation, or attic overflow. Either way, they're set on the driveway or sometimes on the street in front of the house.

The problem seems to be that while PODS are meant to be temporary, some are over-staying their welcome in the neighborhood. According to neighbors' reports, some PODS have been left in place for well over a year.

It's a relatively new phenomenon

and most cities and towns in the metro area haven't yet included PODS in the local codes. A search of websites and a telephone survey of codes offices revealed that Leawood is the only municipality that has specific PODS restrictions. Leawood regulates the placement on PODS (offstreet) and reinforces the temporary nature of POD storage by limiting the placement to no more than thirty days.

Other towns indicated that "the same rules that apply to dumpsters, apply to PODS," but that seems to be an assumption, not a regulation.

The growing popularity of PODS, their tendency to become just a little too convenient and the annoyance factor for neighbors when PODS become semipermanent fixtures, makes this a worthy issue for the Homes Associations of Kansas City (HAKC).

On behalf of the homeowners, the HAKC staff has contacted all municipalities that include HAKC neighborhoods, expressing concern and asking for specific regulations.

If you notice a PODS unit that is staying too long in your neighborhood, please contact the HAKC office at (913) 385-2440. They will notify the homeowner about the complaint and send a copy of that letter to the city to reinforce HAKC's observation that prolonged PODS are becoming a nuisance.

Numerous other owners or residents serve on committees or help with special tasks as they arise. Board members and committee members are volunteer leaders who meet regularly to discuss pertinent details about running their neighborhood.



For over sixty years, Homes Associations of the Country Club District (HACCD) has provided management services for area home associations. In 2009, HACCD changed its name to Homes Associations of Kansas City (HAKC) to better reflect its involvement with homes associations throughout the greater Kansas City metropolitan area.





August Security Update

s many of you may recall, our neighborhood experienced a crime spree earlier this year. Fortunately, the primary suspect was apprehended. A bond hearing at the end of May, which resulted in bail being denied, was attended by many local residents from Greenway Fields and adjacent homes associations. Several neighborhood leaders, including your GFHA President, Gina Valentino, were given the opportunity to voice their concerns about area crime and lenient treatment of these criminals. Since then, our neighborhood has seen a significant decrease in crime.

Officer Brent Parsons, head of our KCPD Security Patrol, has provided some further perspectives on local criminal activity. He met with the Metro Patrol Community Interaction Officer and both agree that the criminal element is moving east. They feel this is a direct result of the Metro Task Force, the officers working for neighborhood associations in a pro-active patrol, and each of our individual efforts in our homes association.

Officer Parsons wants us to be vigilant in helping us become harder targets. He stresses that we must remove items in plain site, lock doors and keep garages closed.

Your Board encourages you to contact your block captain to ensure you are receiving updates, messages concerning our neighborhood and to feel connected with your block. Greenway Fields block captains are listed on the HAKC website, *see link below*.
