f. **GFNCID Board Notes**

- GFNCID Board meet June 24, 2017, posted under MO Sunshine law, for special assessment resolution that will increase annual assessment per parcel within the district to \$160/year. Increase will support additional major repair projects in 2018 and will be covered by Clem in Sept Newsletter.
- ii. Additional resolution passed to increase GFHA management fee annually to \$5K from GFNCID funding.
- iii. FYE filing are complete with MO State Ethics committee and letter to City Clerk are complete.
- g. **Board member resignation** with 7 members we are good per bylaws and do not need to fill positions.
 - i. Jeanette is resigning from board to focus on her state association at work
 - ii. John Weber is resigning from board to focus as Boy Scout troop leader.
 - iii. Joe recommended a new neighbor, Kurt Knapstein, who is interested in joining the board, be appointed. Joe will confirm and reach out to him per board request.

h. Landscaping – Beth / Clem

- i. Park Trees Prune by KCMO Forestry Dept. pending date KCMO Forestry will prune all trees.
- ii. Statues at the park -
 - 1. Storage cost \$150/mo.
 - 2. We have a bid from ArtWorks for rehab of old statues, approx. \$7K for face re-sculpt work, epoxy injection in all cracks, 10-year water sealant. With new pad and all labor to return these to park we are looking close to \$10K. If we go this route ArtWork KC needs 50% upfront payment around \$3,500. Clem MOTION APPROVED- pay \$3500 upfront to Creative Sculpture and Restoration from GFHA Certificate of Deposit.
 - 3. Beth is planning to write a grant asking for funding from our bank and other local companies within the KC Metro.
- iii. Park Benches Arrived with 1 missing part. Clem is planning to put together and place by end of Aug 2017 onto the concrete pads at the park.
- iv. Arches Valley Complete with all in cost around \$5,000. Stone mason advised residents to keep vines from growing on the stone columns as they will destroy the old stone.
- v. Monkey Island landscape On schedule for mid Sept start with replanting and red granite path, red bud addition and new Autumn Blaze Maple planting this fall just north of the garden. Monkey Island lawn will be reseeded late Sept after work is complete with the landscape bed.
- vi. Plan on a fall reseeding of park Monday Aug. 28th.
- vii. Additional tree planting locations at "heat islands" along 63rd St. Homeowners will be approached to make sure they want and will care for a new tree in easement.
- viii. PIAC request- Beth submitted a request for funding for blue sidewalk tile replacement. Try to get individual letters of support from homeowners, be submitted to GFHA and submitted to the city together. Total Cost: \$86,000, GFHA has approved \$4,000 to the project.
